SECTION 4: First-aid measures

Description of necessary first-aid measures

If inhaled If inhaled, remove from contaminated area to fresh air immediately. Apply artificial

respiration if not breathing. If breathing is difficult, give oxygen. Immediately obtain

medical aid if cough or other symptoms appear.

In case of skin contact Immediately remove contaminated clothing and wash affected area with water for at

least 15 minutes. Ensure contaminated clothing is washed before re-use. Seek

immediate medical advice /attention depending on the severity.

In case of eye contact Immediately irrigate with copious quantity of water for at least 15 minutes. Eyelids to

be held open. In all cases of eye contamination it is a sensible precaution to seek

medical advice.

SECTION 5: Fire-fighting measures

Suitable extinguishing media

Small fire: USE FLOODING QUANTITIES OF WATER. DO NOT use dry chemicals, CO2 or foam.

If safe to do so, move undamaged containers from the fire area. DO NOT move cargo if cargo has been exposed to heat.

Large fire: Flood fire area with water from a protected position.

Cool containers with flooding quantities of water until well after the fire is out. If impossible, withdraw from area and let it burn. Avoid getting water inside the containers; a violent reaction may occur. Dam fire control water for later disposal.

Specific hazards arising from the chemical

Will accelerate burning when involved in a fire. May explode on heating, shock, friction or contamination. Some will react explosively with hydrocarbons (fuels). May ignite combustibles (wood, paper, clothing, etc). Fire may produce irritating, poisonous, and/or corrosive gases. Containers may explode on heating. Runoff may create fire or explosion hazard.

Special protective actions for fire-fighters

Fire fighters should wear full protective clothing and self-contained breathing apparatus (SCBA) operated in positive pressure mode. Fight fire from safe location.

Methods and materials for containment and cleaning up

Do not contaminate. Keep combustibles (wood, paper, clothing, oil, etc.) away from the spilled material. Do NOT touch damaged containers or spilled material unless wearing appropriate protective clothing. Use water spray to knock down vapours or divert vapour clouds. Prevent entry into waterways, drains or confined areas. Prevent exposure to heat.

Dry Spill: Use clean non-sparking tools to transfer material to a clean, dry plastic container and cover loosely. Move container from spill area.

Small Liquid Spill: Use a non-combustible material like vermiculite, sand or earth to soak up the product and place in a loosely-covered container for later disposal.

Large Liquid Spill:

SECTION 7: Handling and storage

Precautions for safe handling

Avoid generation or accumulation of dusts. Avoid prolonged or repeated contact with skin, eyes and clothing. Use in well ventilated areas away from all ignition sources. In case of insufficient ventilation, wear suitable respiratory equipment. Wash hands and face thoroughly after working with material. Contaminated clothing should be removed and washed before reuse.

Conditions for safe storage, including any incompatibilities

Store in a cool,dry place. Store in well ventilated area. Keep containers closed at all times. Keep away from direct sunlight and other sources of heat or ignition. Keep away from moisture. This product should not be stored on wooden floors. Store away from combustible materials.

SECTION 8: Exposure controls/personal protection

Appropriate engineering controls

Acute toxicity

Ingestion: Harmful if swallowed. Irritation of mucous membranes in the gastrointestinal tract. Corrosive. Symptoms include headache, abdominal pain, diarrhoea, nausea and vomiting.
